CAREER SUMMARY

Academic leader with distinctive qualities, expertise, experience, and focus. The overarching goal of my career is to utilize science to make positive social change creating a society in which all people are supported in reaching their full potential. I have worked to achieve this goal by advancing research, scholarship, and practice related to addressing the most pressing challenges impacting our diverse local and global communities. Drawing on my expertise in health-related behavior change intervention, culturally-informed programming, program evaluation, applied research methodology, statistical analysis, and findings dissemination, I have advanced scholarship and practice in three main areas: 1) health-related behavior change intervention, 2) culturally-informed intervention and research, and 3) translation of research to practice.

My approach and values exemplify integrity, compassion, exploration, adaptation, inclusion, and determination. My work is guided by values of respect, collaboration, strength-based approaches, appreciation of diversity, investment in community, and passion for a more equitable world. I work in true collaboration with coworkers, colleagues, community, and community supportive entities; such as healthcare providers, national governmental funding agencies, private foundations, local government, law enforcement, and institutes of higher education. I concentrate on fostering collaboration, building trust, achieving results, and leveraging resources. The exploration of innovative approaches to addressing community and institutional needs and challenges is integral to my work. These approaches include ongoing adaptation within and between projects and initiatives in response to emerging needs and challenges, research findings, lessons learned, and funding opportunities.

As interim director of WISE, I led WISE in achieving its mission, vision, and goals. I sustained existing programming, oversaw activities, and managed WISE program coordinators.

Position Responsibilities:

- 45% of my fulltime position at the University of Arizona (UArizona) is for directorship of SIROW. The other 55% of my position is for research and service activities supporting my independent research portfolio.
- My overarching goal as Director is to advance SIROW's mission to develop, conduct, and disseminate collaborative outreach, education, intervention, and research projects of importance to diverse groups. By advancing this mission, I strive to enhance and expand

- SIROW's contribution to a more just and equitable society for all.
- SIROW is multidisciplinary with expertise related to gender, health, family, sexuality, education, employment, adult and juvenile justice, immigration, public policy, cultural diversity, history, and other issues that impact diverse groups. Multidisciplinary theoretical perspectives with the utilization of both qualitative and quantitative methods drive our applied research activities.
- I support 29 SIROW employees, including 7 research professors, 3 research social scientists, 1 business manager, and 18 staff in various roles. I currently have 9 employees that report directly to me. One of these is the Director of <u>SIROW's Women in Science and Engineering (WISE) Program</u>. In addition, SIROW has had about 30 paid student employees per semester.
- SIROW currently has 46 active collaborative extramurally-funded community-focused research, action, and advocacy projects housed at our campus and 2 community-based sites.
- SIROW currently collaborates with 74 community agency collaborators, such as behavioral and physical healthcare providers, schools, governmental agencies, law enforcement, Tribal Communities, and community-based service providers. SIROW also collaborates with 43 UArizona department/college/unit partners, and 17 other university partners. In addition, I co-lead the SIROW Regional Partners Network that includes partners from 35 public and private universities from Arizona, Colorado, Nevada, New Mexico, Texas, Utah, Wyoming, and the U.S.-Mexico border region.
- SIROW is funded mainly by extramural funding from grants and contracts currently totaling \$3.5 million per year. This funding is obtained from a variety of entities.
 Because our work is truly collaborative, almost every one of the grants we are funded by involves us as a subcontractor or multiple community-based entities as subcontractors to us. I oversee all of those contracts.

Select Administrative Leadership Accomplishments:

- When I became Director, I faced 3 large grant-funded projects nearing project end dates with depleted funds to sustain employees between grants and, consequently, faced the possibility of having to lay-off 5 employees. With my encouragement, guidance, and collaboration, SIROW researchers and I were able to bring in funding to not only retain all SIROW employees and advance their work, but also to grow SIROW.
- Within 2.5 years of me becoming Director, SIROW obtained enough extramural funding to employ 3 additional advanced researchers who bring experience in community-focused translational and policy research in the areas of behavioral and medical healthcare access and practice; poverty and homelessness inequality; public health emergency preparedness and response; hospital and healthcare readiness; and competency and capability-based workforce development. In addition, we have added more than 5 project-supportive staff positions.
- Led SIROW through a successful periodic review and reauthorization UArizona process for research institutes.
- Upon being appointed Director, I led the creation of a <u>5-year strategic plan</u> informed by

diverse stakeholder voices and perspectives leading to informed, thoughtful, and achievable strategic goals and initiatives. The SIROW Strategic Plan 2019-2023 set the goals for SIROW and further specified my goals as Director. In pursuit of these goals, listed below as Pillars 1 to 4, I work to build trust, foster collaboration, maximize resources, achieve results, and promote inclusive excellence. (With my direction, SIROW has recently completed the development of the <u>SIROW Strategic Plan 2024-2028.</u>)

Goals and Primary Accomplishments Achieved by SIROW Within 7 Years of my Directorship SIROW's Pillar 1: Advance projects to address social inequalities and group-based disparities.

- Played a key role in securing over \$24 million in extramural funding to support SIROW and partners' collaborative work, with over \$3.8 million to SIROW and over \$19 million to UArizona.
- Supported other SIROW researchers to secure more than \$42 million in additional grant funds to support SIROW and partners' collaborative work.
- Increased number of extramurally funded active research, action, and advocacy projects from 35 to 51 in 2022 to the current 46, which includes a \$7.5 million grantfunded project.
- Diversified extramural funding sources to include, for example, Arnold Ventures, Garcia Family Foundation, and USDA.
- Relevant to all four pillars, I am leading the efforts to have UArizona host the American Society for Evidence-based Policing annual conference in spring 2025.

SIROW's Pillar 2: Promote SIROW as a premier innovative resource and research center.

- Increased media coverage of SIROW work, remodeled <u>SIROW's webpage</u>, and otherwise increased dissemination of SIROW work via research briefs, white papers, and scholarly publications. Scholarly publication alone increased from 6 in 2018 to 14 in 2021, 12 in 2022, and 10 in 2023.
- Established the SIROW LinkedIn page with continuous efforts to increase SIROW's LinkedIn network and posting of 1-2 posts per week promoting SIROW.

SIROW's Pillar 3: Contribute SIROW expertise as an innovative resource.

Conceptualized and led the development of <u>SIROW's online MA program in Program Design & Evaluation</u> and co-led the development of an associated <u>PhD minor program</u> and <u>3 associated graduate certificate programs</u> by which students from around the world learn and practice the execution, application, and translation of research to address the most pressing challenges impacting our local and global communities.

<u>SIROW's Pillar 4</u>: Engage allies and build collaborative relationships.

 Increased number of active partnerships to 74 community partners, 43 UArizona partners, 52 other university and community group partners, including the SIROW Regional Partners.

Leadership Assessment:

In February 2021, I partnered with UArizona's Office of Learning and Organizational Development to conduct a 360 Leadership Assessment related to my directorship of SIROW. SIROW personnel, College of Social and Behavioral Sciences (SBS) deans, and

other key representatives of the dean's office evaluated me in four key areas.

Overall, I was rated positively across all categories. On average, I was rated above 5 on a scale ranging from 1 to 6 (most positive rating) in all four categories.
